Trinity Christian School sponsors a gift-card/TRIP program (Tuition Reduction Incentive Program). The gift cards you purchase through TCS generate rebates from participating retailers. Fifty percent of these rebates will be applied to the TCS Annual Fund which helps reduce all Trinity family tuition amounts and are not considered a charitable contribution by the IRS. The remaining 50% can be sent to you in the form of a check or be used as your charitable contribution to TCS. Rebate amounts will be applied only when gift cards are purchased at ShopWithScrip.com using your account number **and** PrestoPay. In consideration of TCS' participation in the TRIP program and our desire to make your tuition as affordable as possible, TCS offers two options (please initial one):

_____ I would like my TRIP rebates to be **mailed to me once a year in the form of a check**. The remaining 50% of the rebates will be retained by TCS for the Annual Fund. (The portion retained by TCS is not considered a charitable gift by the IRS.)

_____ I would like the portion of TRIP rebates to which I am otherwise entitled to be **applied as a charitable contribution** to the TCS Annual Fund. This portion, charitably donated to the TCS Annual Fund, would be considered a charitable contribution by the IRS.

Acknowledgements:

- (1) This agreement will be effective immediately and will be automatically renewed annually thereafter unless terminated by either party pursuant to the terms of this Agreement. Rebates will be issued in the form of a check twice a year.
- (2) Rebates will be issued only when gift cards are purchased online at ShopWithScrip.com*, using your account number and PrestoPay. All other purchases, including Drive Thru TRIP, are not eligible for this rebate program, and any rebate amount will go 100% to the TCS Annual Fund. (*The TCS ShopWithScrip.com **Enrollment Code** is **99AEF3213368**.)
- (3) The total rebate earned each cycle must exceed \$20 in order to receive a rebate check for your purchases. (This will result in a minimum \$10 check issued to you.) Any portions under \$20 will be applied to the Annual Fund.
- (4) TCS is not responsible for any lost or stolen gift cards. TCS does not track individual gift card serial numbers.
- (5) Gift cards/TRIP cannot be refunded or exchanged once purchased.
- (6) Extended family members and friends can participate in this TRIP program.
- (7) With respect to your charitable contributions, TCS will provide you with all required acknowledgements under sections 170(f)(8) and 170(f)(17) of the Internal Revenue Code.
- (8) You shall be responsible to TCS for any and all TCS losses incurred from insufficient funds in your account to cover your gift card purchases;

Also acknowledged: (i) no employment or partnership arrangement is created as a result of our relationship; (ii) you are the owner of the gift cards purchased on your behalf; (iii) TCS reserves the right to limit or decline the sale of gift cards to any individual or group; (iv) TCS makes no representations or warranties of any kind with respect to the gift cards purchased on your behalf; and (v) this agreement can be terminated by either party upon 30 days advance notice to the other.
